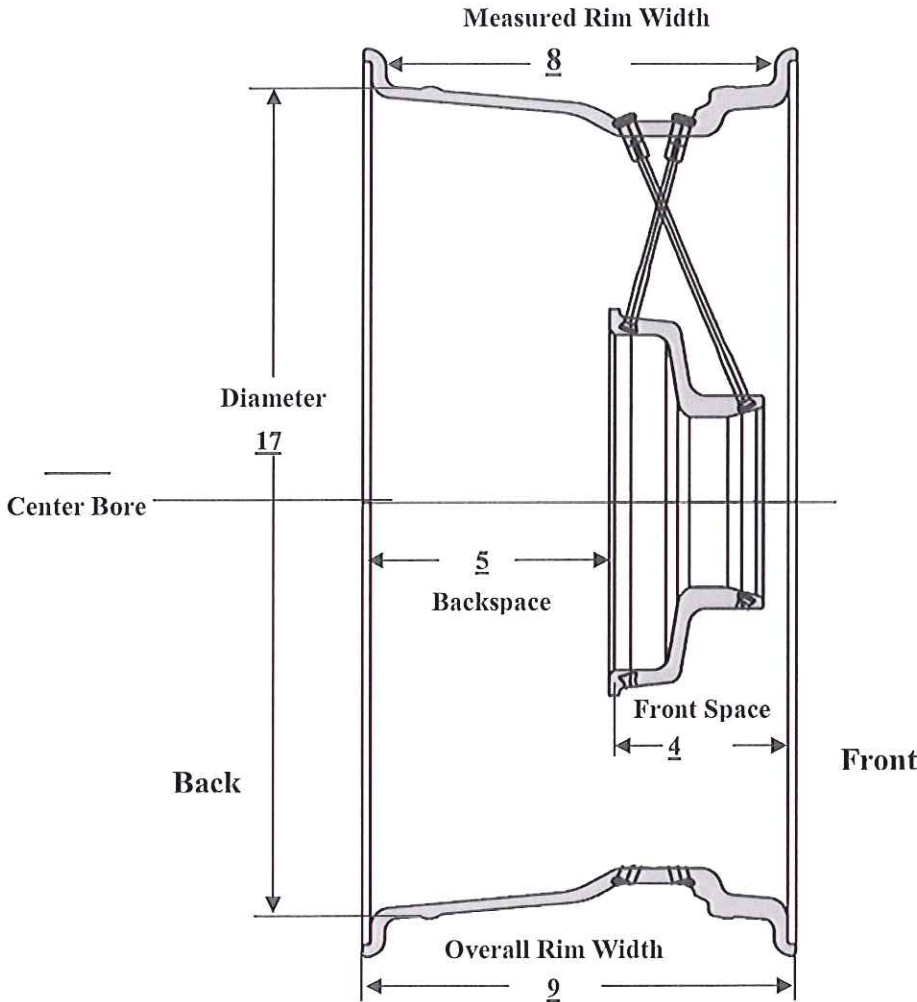

All order terms and conditions for Dayton Wheel Concepts, Inc. as described below apply to wheel sales for Dayton Wire Wheel and American Wire Wheel.

### Ordering

All wheel orders should be faxed or mailed to Dayton Wheel Concepts, Inc. at 937-438-1215 or [sales@dwpc.com](mailto:sales@dwpc.com). Phone orders may be called in at 1-800-862-6000 from 8AM TO 5PM M-F, EST.

### Prices/ Discount

Prices are displayed in US Dollars, subject to change without notice. Any changes will be discussed at the time your order is placed. Prices do not include shipping. All prices in this book are subject to change without notice. Dayton Wheel Concepts, Inc. is not liable for misprints.

**Payment:** Check or credit card payment is due prior to shipment on all orders. Special order wheels are charged 50% at the time of order and 50% prior to shipment. There is no return or exchange on special order wheels. Cancellation of a special order will result in the loss of deposit.

### Drop Ship

Any drop ship orders will be charged a \$20 flat fee for special handling.

### Return Information

We cannot accept unauthorized returns. Please call us regarding for assistance with an order or return authorization number. Returned parts must be unused, in original condition, and in original packaging and received by Dayton Wheel Concepts, Inc. no later than 30 days after sale for a refund. No return will be accepted without a copy of the original invoice. Returned items are thoroughly inspected prior to determination of credit, replacement or refusal. There is no refund on special order items. A 20% restocking fee will be charged to all returns not due to our error. There is no refund for a shipping charge on returned items.

### Damaged Items

When Packages appear damaged on arrival, state in writing the condition of the container over your signature on the receipt. If damage is discovered after opening the container, notify the carrier immediately. We provide good merchandise properly packaged to the carrier. Claims for damage must be directed to the carrier, not to Dayton Wheel Concepts, Inc.

### Guarantee

Defective merchandise must be returned at customer's expense for replacement. We will replace defective parts, but cannot accept responsibility for inconvenience or losses occasioned by their use or labor involved in their installation and removal. There is no warranty if parts have become defective due to faulty installation or abuse. There is no warranty, expressed or implied, for any parts or work used for competition, or performance driving school events. We reserve the right to withhold refund until defective part has been examined and tested.

### Product Use

Many items we sell are for use off-road or in a controlled competition environment. It is the customer's responsibility to ensure that items purchased are legal and safe for their intended use. ### Investigation of previously transacted items

Any investigation or copies requested by a customer that has been determined already submitted will require a handling fee of \$50.00 per item net payable in customer agreed terms.

### Warranty for wheels

All Dayton Wheel Concepts, Inc. wheels are warranted to the original owner for;

- o Three (3) years from date of purchase – Dayton Wire Wheels
- o One (1) year from date of purchase – American Wire Wheels

for defects in material and/or workmanship under normal and intended use. Dayton Wheel Concepts, Inc. agrees to repair or replace wheels, at the sole discretion of Dayton Wheel Concepts, Inc. Dayton Wheel Concepts, Inc. is not responsible for finish problems due to neglect by the customer. Wheels that have been determined to have been damaged by a tire-mounting machine will be repaired at the customer's expense. Transfer of title of any Dayton Wheel Concepts, Inc. product by the original owner voids the warranty. Dayton Wheel Concepts, Inc. is not responsible for any damage to vehicle or labor cost incurred as a result of failure of warranted items. Dayton Wheel Concepts, Inc.'s warranty is limited to the purchase price of the product. *Wheels returned for warranty inspection must be accompanied by a copy of your receipt.*

**Warranty claims will not be approved until Dayton Wheel Concepts, Inc. inspects the product.**

### Claims

Claims for damage, shortage or manufacturing error must be made within five (5) business days from the receipt of shipment by calling 1 (800)862-6000. Claims for damage as a result of carrier's negligence must be held at the customer location pending disposition from carrier. Claims not made within this period will not be honored by Dayton Wheel Concepts, Inc. Claims for finish problems must be made prior to installing accessories or mounting tires.

### Important

All defective returns will be reviewed by quality control personnel. Any defects not found to be Dayton Wheel Concepts, Inc.'s responsibility will be rejected and returned to the sender at their expense. Defects in finish will not be covered under warranty if:

1. Damage occurred during installation
2. Damage to finish is due to improper care, use of caustic material for cleaning, or neglect
3. The item was sold as a second or blemished product
